roject Hope Alliance (PHA) aims to end homelessness in our community, one child at a time. When children experience housing instability, the added stress and uncertainty makes it difficult for achievement in school and in life. However, homeless children are often hidden in plain sight. "Instead of sleeping on park benches or in tents outside, they sleep in cars, motels, garages, couch surf, and often double/ triple shared spaces with other families," said Jennifer Friend, CEO of Project Hope Alliance.

PHA believes in the transformative power of education and prioritize the needs of homeless children. The organization has established formal partnerships with local schools and districts, such as Newport Mesa Unified School District. Jennifer said, "We keep kids

at the center and show up every day on their school campuses."

This inspiring artwork symbolizes the incredible work that this local non-profit does to provide resources for homeless children in our community.

Professional case managers support students by removing barriers caused by homelessness, providing resources like food and hygiene products, and offering academic and life goal assistance through one-on-one case management. Major milestones, such as graduation, obtaining a driver's license, college acceptance, and securing a first job, are celebrated with the students.

Before leading the organization, Jennifer Friend served as a volunteer board member and has a deeply personal connection to the cause, fueled by her own experiences with homelessness. She shared that in her childhood and teen years, her family often moved between motels or stayed with friends due to housing instability. Jennifer said, "I realized the purpose of my story is to lift the invisibility of more than 23,000 students experiencing homelessness in Orange County's schools and show up for these amazing kids so they can access and excel in their education and end the cycle of generational homelessness." A former trial lawyer, Jennifer left her law firm partnership in 2013 to serve as the CEO of PHA.

Jennifer finds daily inspiration in the children she serves. "Like Mary Poppins, I truly believe that anything can happen if you let it. Every day I see the spirit of possibility in our kids and youth. Their tenacity, grit, creativity, and courage drive me to eliminate the obstacles that homelessness brings into their lives so they can dream and bring their dreams to fruition."



According to Trellis, "Over 900


volunteers completed 50 projects."
